Great Backyard Bird Count

Have you ever wanted to participate in a large-scale research study? Well, now is your chance, because it is time for the 2012 Great Backyard Bird Count (or GBBC), which is scheduled from February 17 - 20. The Great Backyard Bird Count is a joint project of Audubon, The Cornell Lab of Ornithology, and Bird Studies Canada. The goal of the GBBC is to take a snapshot of where birds are across North America, and everyone, from novices to experienced birders, is invited to participate. Audubon Chief Scientist, Gary Langham says "The Great Backyard Bird Count is a perfect example of Citizen Science." This is a project that would not be possible without the help of thousands of volunteers, and it is a great way to learn more about the birds in your area.

So what do you have to do to participate in the GBBC? According to the GBBC web site (www.birdsource.org/gbbc) "it's as easy as 1, 2, 3!"

1. Plan to count birds for at least 15 minutes on one or more days of the count. You can count for longer than that if you wish! Count birds in as many places and on as many days as you like—one day, two days, or all four days. Submit a separate checklist for each new day. You can also submit more than one checklist

per day if you count in other locations on that day.

2. Count the greatest number of individuals of each species that you see together at any one time. You may find it helpful to print out your regional bird checklist to get an idea of the kinds of birds you're likely to see in your area in February, and note the highest number of each species you see on the checklist.

3. When you're finished, enter your results through our CCAS web page. You'll see a button marked "Enter Your Checklists!" on the home page beginning on the first day of the count. It will remain active until the deadline for data submission.

Counts can be taken in backyards, parks, along trails, and in urban settings. You can conduct either a "standing count" where you stay in one place, or a "traveling count" if you are hiking along a trail or walking through a park. The methods used for these two types of counts are slightly different, so check the instructions on the GBBC web site.

Champaign County Audubon Society will conduct a count at the Anita Purves Nature Center (1505 North Broadway Avenue, Urbana) on Saturday, February 18, from 9:00 am to 4:00 pm. Local Audubon members will be on-hand to help identify bird species and to answer questions about bird habitat and behavior. The bird observation room at the nature center is accessible, and a great place to participate in the count while staying warm. We hope to see you there!

Recent Bird Sightings: FIELD NOTES from Beth Chato

Highlight of the winter must be Snowy Owls, probably at least 4 in Champaign County. One now resides at the U/I Wildlife Clinic where it is being treated for a broken wing. A close tie with the Snowy Owls is the late lingering Baltimore Oriole in the Forestry. Others of note include Trumpeter Swan, Ross' Goose, Orange-crowned Warbler, Long-eared and Short-eared Owls, Brewer's Blackbird, and Redpolls.

Tar Sands Oil Pipeline

By now everyone has heard that Obama refused to sign off on the XL pipeline that would carry tar sand oil from Alberta to Texas over the Ogallala aquifer. This does not mean that this proposal is dead--the oil companies will do all they can to keep it going, but maybe enough sanity will prevail for an alternate, less hazardous route to be determined. Meanwhile--another alternate has been proposed called Northern Gateway pipeline. This would transport the same tar sands crude to the British Columbia coast to be loaded onto tankers bound for Asia & the U.S. Just imagine the potential for spills from that one.

Mines vs Parks

Here in Illinois, a company wants to put a sand-mining operation on the edge of Starved Rock State Park, which would certainly have an adverse impact on one of the jewels of the Illinois park system. This is to be approved because somebody uttered the sacred word "jobs". No account taken of the jobs that would be LOST if fewer people visited Starved Rock. Now take this same type of proposal and ratchet it up to a national scale: this time the mine is for coal and the park is Bryce Canyon. Yes, the state of Utah and the Obama administration seek to expand a coal mine located 10 miles from Bryce Canyon to cover 3500 acres and have heavy-duty diesel trucks rumbling down a 2-lane highway 24 hours a day. Is nothing sacred?

February 11 th: Meadowbrook 9 -11 am. Meet at Race Street parking lot.



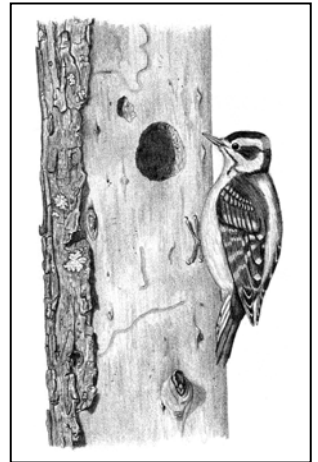
